

APPENDIX 1 – Key Personnel, Accountabilities and Responsibilities

Key:	Duties:
Principal	Statutory for the Principal to maintain overall responsibility; liaise with Designated Officer as and when necessary; audit CPOMS 3 times per year
Designated Safeguarding Lead	Statutory for the DSL to be part of the Academy SLT; maintain overall day to day responsibility; undertake refresher training every 2 years* and deliver whole staff training annually (as outlined in the Keeping Children Safe in Education document)/ not less than termly; attend BWT training opportunities; maintain accurate records through CPOMS; ensure knowledge of appropriate policies; liaise with Safeguarding Governor *Where a DSL’s training has expired, BWT will allow the DSL to continue in the role for a maximum period of 3 months provided that a refresher training session has been booked.
Deputy Designated Safeguarding Lead	Refer to and liaise with the Local Authority and other agencies in line with <i>“Working Together to Safeguard Children 2015”</i> ; undertake refresher training every 2 years*; act as a source of support, advice and expertise to all staff on safeguarding matters; inform DSL of any issues including those progressing to S47; attend BWT training opportunities; maintain accurate records through CPOMS; liaise with Safeguarding Governor; encourage a culture of listening to students and promoting their wishes and feelings *Where a DDSL’s training has expired, BWT will allow the DDSL to continue in the role for a maximum period of 3 months provided that a refresher training session has been booked.
